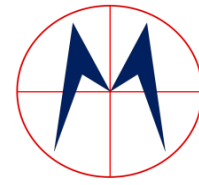

Position Overview

Maintains quality standards by approving incoming materials, in-process production, and finished products, recording quality results.

Essential Job Functions and Responsibilities

- Performs visual inspections on various products using equipment for which employee has been trained.
- Reads and understands instructions, procedures, routing sheets and other required documentation.
- Follow instructions and procedures to ensure that quality of work is met.
- Performs work on schedule so as to ensure quantity of production is met on time.
- Processes paperwork and ensures that routing sheets are complete and accurate. Maintains integrity of the product with its lot numbers so that no mixing of product occurs.
- Reports problem to supervisor for resolution. Does not perform any trouble shooting activity without express permission from supervisor.
- Uses measuring instruments and other devices to verify specifications of products.
- Uses mathematical skills as required to perform calculations necessary to the performance of required inspection tests.
- Uses inspection equipment according to operating instructions.
- Cleans and maintains equipment, tools and work area.
- Records all labor and production information in accordance with department procedures.
- Follows code of conduct in regards to work habits and behaviors.

Scope

- This position reports to Quality Control Manager and does not have any reports.

Requirements / Qualifications

- High School graduate or GED.
- 18 years of age or older.
- Employee must show an aptitude for inspection. A willingness to perform the physical functions required and must be hands on with handling parts or working on machinery.
- Mathematical skills; i.e. basic math; algebra and geometry.
- Basic reading skills of English at a level sufficient to read work orders, operating instructions, company policies and safety rules.
- Maintains good attendance and punctuality.

Preferred Qualifications

- Blueprint reading skills.

Physical Requirements

- Employee is required to stand and sit for long periods of time. Must be able to walk and lift or carry parts or other items weighing up to 40 pounds throughout the inspection dept. Uses arms, hands and fingers to operate tools, computers and other equipment. Must have near vision to be able to read, focus and make adjustments in performing duties.
- Pass eye exam.

Work Environment

- Primary work is done under laboratory type conditions. Noise level is low to moderate. Employee may be exposed to chemicals, moving machinery or equipments requiring the use of personal protective equipment.
